Church Council Nominations – (Jeff/Matt)

The Church Council needs three new members starting in January 2022. Jeff and Matt bring 4 people for our consideration:

The Council will only have 9 voting members, the church staff will only have 1 vote, Angie Duran and Chris Amdahl will serve on cancel but they will not have a vote.

Mission Committee Charter – (Matt):

The Mission Committee is made up of nine people. They are given 6.5% of the church budget is allocated to the mission committee. A charter was written mostly by Sarah Manning out-lining how the Mission Committee is supposed to function.

90 Day Sprint Update (Angie):
